# The Higher Education Success Factor (HESF) as an Evidence-Based Implementation Tool

## Introduction: The Evolution of Student Success

- The Australian Universities Accord represents a paradigm shift in conceptualising student success
- **Access → Achievement → Rightful Success**
- HESF provides the evidence-based framework to operationalize this evolution
- Moving to 80% tertiary attainment by 2050 requires systematic implementation



# Key Findings from the HESF framework

## The critical factors include:

- Social environment (institutional support, inclusive policies)
- Physical environment (facilities, housing, safety)
- Health and economic wellbeing (financial stability, mental/physical health)
- Individual characteristics (motivation, resilience)

## 2. Based on surveys of 2,528 Australian graduates (2018-2022)

- The research identified that health and well-being are the most significant factors influencing completion rates, followed by individual characteristics and economic conditions.
- 3. Among university graduates, Indigenous students' economic challenges were identified as a critical barrier, underscoring the need for targeted support that addresses both financial and non-financial factors.

# The Student Success Paradigm Shift

## Historical Student Success Approaches:

### Access Era

Focus on enrolment numbers with limited attention to outcomes

### Achievement Era

Emphasis on completion metrics without equity consideration

### Rightful Success Era

Holistic approach addressing systemic barriers

*"Australia should grow the tertiary education system and improve skills through attainment targets and increased equity, meeting student needs and enabling fit-for-purpose research"*

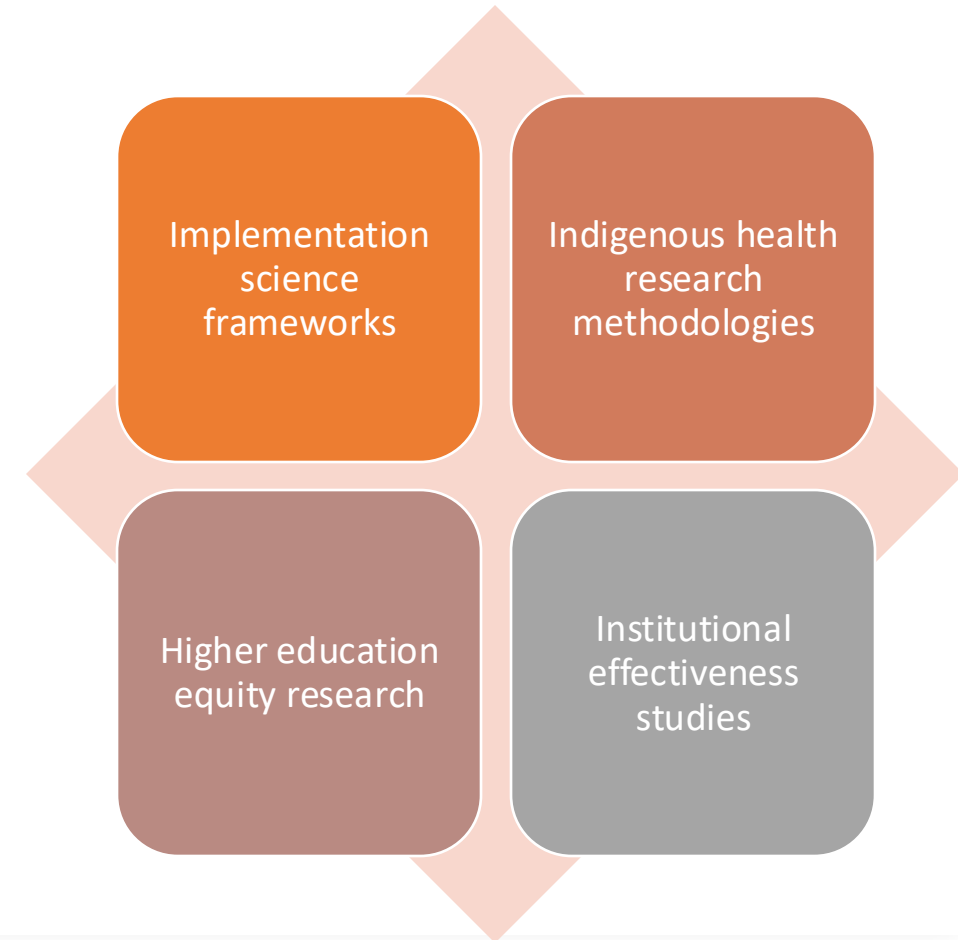


# HESF: Enabling Rightful Success Through Evidence-Based Implementation

## Rightful Success Core Principles:

1. **Equitable Participation:** Evidence-based approaches to achieve population parity
2. **Holistic Support:** Research-validated comprehensive student support mechanisms
3. **Culturally Responsive Practice:** Evidence-informed approaches to cultural or educative safety
4. **Systems Transformation:** Data-driven institutional change strategies
5. **Outcomes Equity:** Evidence-based interventions for equitable graduate outcomes

# HESF Evidence Integration: Lessons from Indigenous Health Research

## Applying Indigenous Health Research Trends:

- **Shift from Deficit to Strength/Rights-Based Approaches:** Research shows better outcomes
- **Community-Led Implementation:** Evidence of increased effectiveness
- **Cultural Safety Implementation Strategies:** Research-validated approaches
- **Two-Eyed Seeing Implementation Model:** Empirically supported knowledge integration

## Evidence-Based Implementation Strategies:

- **Cultural Safety Assessment Tools:** Validated measurement instruments
- **Strength/Rights Based Intervention Protocols:** Evidence-informed support approaches
- **Community Partnership Impact Framework:** Structured engagement methodologies
- **Knowledge Integration Measurement:** Empirical assessment of knowledge recognition



# HESF Funding Model: Evidence-Based Resource Allocation for Rightful Success

## Needs-Based Funding Methodology:

- **Equity Support Cost Evidence:** Research on actual costs of supporting diverse students
- **Regional Delivery Evidence Base:** Data on additional costs in regional contexts
- **Implementation Infrastructure Assessment:** Measuring capacity requirements
- **Success-Linked Funding Formula:** Evidence-based incentive structures

### Accord Evidence:

*"The Review recommended a needs-based system that covers the costs of providing courses, taking into account the higher costs of educating equity groups and providing regional education"*

-  **Student Experience Assessment:** Evidence-based measurement instruments
-  **Progress Milestone Tracking:** Research on critical progression points
-  **Post-Graduation Outcome Measures:** Validated long-term success indicators

## Data Infrastructure for Evidence Generation:

-  **Longitudinal Tracking System:** Research-informed long-term monitoring
-  **Multi-level Analysis Framework:** Evidence on institutional and system factors
-  **Implementation-Outcomes Correlation:** Linking practices to equitable results
-  **Predictive Analytics Models:** Evidence-based early identification

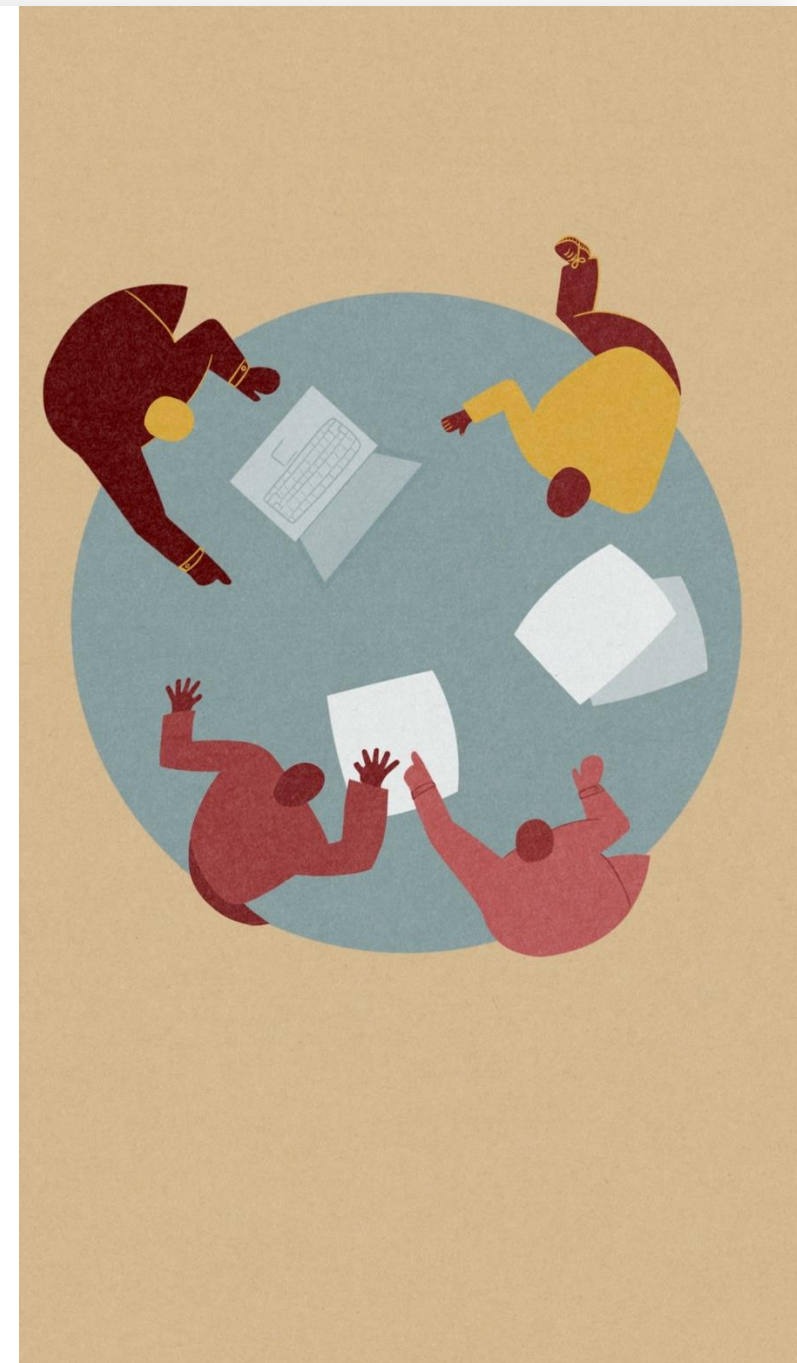
# HESF Implementation for First Nations Student Rightful Success

## Evidence-Based Implementation Strategies:

- **Self-Determination Implementation Framework:** Research on authentic leadership
- **Cultural or 'Good' Governance Models:** Evidence on effective decision-making structures
- **Indigenous Knowledges/perspectives Integration:** Research on curriculum and teaching approaches
- **Community Benefit Assessment:** Validated impact measurement tools

## Measuring Implementation Effectiveness:

- **Cultural Responsiveness Implementation Metrics:** Beyond traditional outcomes
- **Community Engagement Quality Measures:** Evidence-based partnership assessment
- **Indigenous Student Journey Model:** Research on culturally-grounded support
- **Knowledge Recognition Assessment:** Measuring respect for Indigenous knowledge

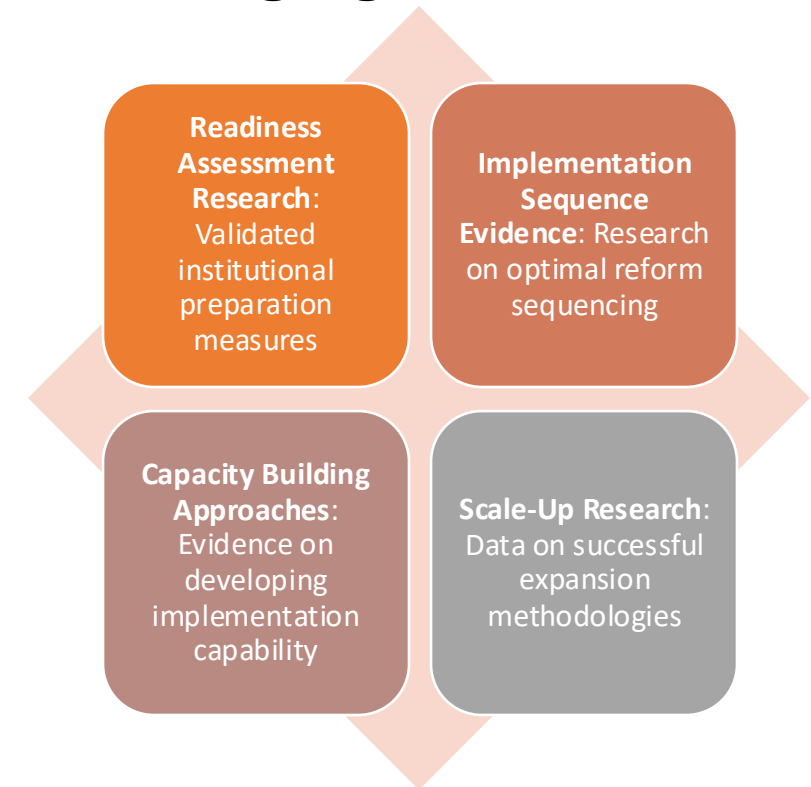


# HESF for Achieving 80% Attainment With Equity

## Evidence-Based Growth Strategy:

- **Equity Pipeline Research:** Evidence on pathways from school to tertiary education
- **Barrier Removal Evidence:** Research on overcoming participation obstacles
- **Regional Capacity Building:** Evidence-based approaches to regional delivery
- **Lifelong Learning Research:** Data on supporting diverse age groups

# **The HESF Rightful Success Implementation Pathway**

## **Stage 1: Evidence-Based Foundation (2024-2026)**

- Establishing baseline equity metrics using validated instruments
- Building implementation capacity based on research evidence
- Developing data infrastructure informed by implementation research
- Creating communities of practice around evidence-based strategies

## **Stage 2: Equity-Focused Implementation (2026-2030)**

- Scaling evidence-based interventions for equity groups
- Implementing research-validated support frameworks
- Applying data-driven continuous improvement cycles
- Building evidence through implementation research
